## Thursday 14th February 2013 – Strategic discussion

Hours: 14,00 - 18,00

The discussion should cover both the impacts already achieved by previous projects and those foreseen in the future to be obtained by DCH-RP.

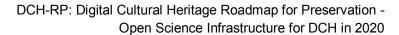
The first step in the discussion is to measure the impact delivered by DC-NET and INDICATE . To this regard, each CH partner should present the situation in its respective country:

- 1. Amount of the investments committed by national authorities on the DCH e-infrastructure within national programmes and projects;
- 2. The influence obtained by the partner in the national programming, directly, or through other institutions; e.g.: how are you involved in national programming for the e-infrastructures? what did you do towards your national authorities to put emphasis on the DC-NET priorities? which priorities of DC-NET are in the national programmes?
- 3. The role of the partner in the national projects, directly, or through other institutions; e.g. how are you involved in the future execution of the projects which will benefit and use these investments? which priorities of DC-NET are in the work plans of these project?

The discussion should be supported by max 3 slides presented by each CH partner to address the 3 points listed above.

Naturally, the references should focus on factual results, e.g. the real increase of investment for a DCH e-infrastructure, the concrete use of the existing e-infrastructures to activate innovative services that did not exist before, the implementations of new components of e- infrastructures.

Long lists of EC projects on digitisation (e.g. Europeana) are not very useful in this context.





The non-CH partners can contribute if they had a role in the past or are planning to have a role in the future about the implementation of the DCH e-infrastructure.

Following the understanding about impacts, the partners all together should discuss about the JPI and in particular if it is possible and how to obtain the acknowledgement of the theme of the DCH e-infrastructure, acknowledgement that, so far, still, does not exist.

As a final topic, the partners should agree how to improve the strategic direction of the project. For example, it could be discussed the constitution of an executive steering committee composed by the representatives of the countries where the most convincing results have been achieved so far.

This committee could possibly also make use of experiences from other countries that are not yet represented in the DCH-RP consortium, but that have concrete results to be used as example and stimulus for the others.

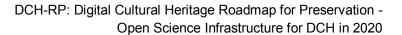



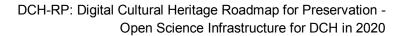

### Cooperation with other projects/institutions

- Marie Veronique: check the possibility for the French Ministry of Culture to get involved in DCH-RP to reinforce the cooperation with DARIAH
- Two different instruments: a Cooperation Agreement to be established with national institutions (also in the frame of WP5) and a Memorandum of Understanding for the cooperation with other projects:
  - DARIAH: Michel Drescher, Borje Justrell to investigate which is the best way to cooperate with DARIAH and if DCH-RP needs to take into account DARIAH services for the Roadmap
  - o EUDAT: EGI, PSNC to establish contacts
  - SCIDIP-ES: PROMOTER to establish contacts
  - o CHAIN-REDS: Roberto Barbera





- Organise workshops with invited guests in the occasion of the plenary meetings: Borje will
  organise a workshop on digital preservation in Stockholm on the morning of the first day of

## **Project Management**

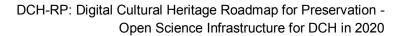

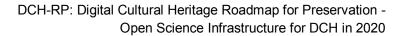
