The present Operational Level Agreement ("the Agreement') is made between **EGI Foundation** (the Customer) and INFN-PADOVA (the Provider) to define the provision and support of the provided services as described hereafter. Representatives and contact information are defined in Section 6.

The main objective of MoBrain is to lower barriers for scientists to access modern e-Science solutions from micro to macro scales. By building on grid- and cloud-based infrastructures and on the existing expertise available within WeNMR<sup>1</sup> and N4U<sup>2</sup> and by integrating molecular structural biology and medical imaging services and data, MoBrain will kick-start the development of a larger, integrated, global science virtual research environment for life and brain scientists worldwide. The projects defined in MoBrain are geared toward facilitating this overall objective, each with specific objectives to reinforce existing services, develop new solutions and pave the path to global competence centre and virtual research environment for transnational research from molecular to brain.

The User is a consortium represented by the Faculty of Science – Chemistry, Utrecht University.

This Agreement is valid from **01/01/2016** to **31/12/2020**.

Once approved, **this Agreement is automatically renewed**, as long as the Provider does not expressed decision to terminate the Agreement at least a month before end date of the Agreement.

The Agreement was discussed and approved by the Customer and the Provider **23/02/2016**.

The Agreement extends the Resource Center OLA<sup>3</sup> with following information:
