The present Operational Level Agreement (“the Agreement”) is made between **EGI Foundation (the Customer)** and **INFN-CATANIA (the Provider)** to define the provision and support of the provided services as described hereafter. Representatives and contact information are defined in Section 6.

This Agreement is valid from **04/01/2016** to **30/09/2019**.

The Agreement was discussed and approved by the Customer and the Provider **31/03/2016**.

The Agreement extends the Corporate-level EGI Operational Level Agreement¹ with following information:

1 The Services

The Services are defined by the following properties:

Technical	This Science Gateway (SG) addresses the requirements coming of the EGI Applications on Demand service (AoDs). This SG is based on the Catania Science Gateway Framework (CSGF) ² , the framework that INFN has developed since 2010 and which is now officially reengineered in the context of the INDIGO-DataCloud project ³ .
Coordination	This activity is responsible for the coordination of the system operation in collaboration with those partners that are in charge of operating other systems (e.g.: GrIDP and eToken servers).
Operation	<ul style="list-style-type: none">• Daily running of the system.• Provisioning of a high availability configuration.• Updating of the service components.
Maintenance	<ul style="list-style-type: none">• Bug fixing, proactive maintenance, improvement of the system.• Documentation.

- Defined as the ability of a service or service component to fulfil its intended function at a specific time or over a calendar month, excluding scheduled maintenance periods.
- Minimum (as a percentage per month): 95%

Quality of Support level

- Medium (see in the Corporate-level EGI Operational Level Agreement).

For escalation and complaints, the Provider contact point shall be used, and the following rules apply.

- In case of repeated violation of the Services targets for four consecutive months, a review of the Agreement and of the Services enhancement plan will take place involving the parties of the Agreement.
- Complaints or concerns about the Services provided should be directed to the Provider contact who will promptly address these concerns. Should the Customer still feel dissatisfied, about either the result of the response or the behaviour of the Provider, EGI Foundation Director director@egi.eu should be informed.

7 Information security and data protection

8 Responsibilities

8.1 Of the Provider

Additional responsibilities of the Provider are as follow:

- Adhere to all applicable operational and security policies and procedures⁵ and to other policy documents referenced therein;
- Policies and procedures under scope: ‘Users’ and ‘Infrastructure’ apply;
- Use communication channel defined in the agreement;
- Attend OMB⁶ and other operations meeting when needed;
- Accept EGI monitoring services provided to measure fulfilment of agreed service level targets;
- Service with associated roles are registered in GOC DB⁷ as site entity under EGI.eu Operations Centre hosting EGI central operations tools⁸.

8.2 Of the Customer

The responsibilities of the customer are:

- Raise any issues deemed necessary to the attention of the Provider;
- Collect requirements from users of the EGI AoD service, share and discuss these on a regular basis with the provider;
- Provides presentation opportunities for the provider at events (workshops, conferences, tutorials) organised for users about the EGI AoD service;
- Facilitate the acknowledgement of the provider in scientific publications written by users of the EGI AoD service;
- Support coordination with other EGI services;
- Provide monitoring to measure fulfilment of agreed service level targets.

9 Review, extensions and termination

There will be reviews of the service performance against service level targets and of this Agreement at planned intervals with the Customer according to the following rules:

- Technical content of the agreement and targets will be reviewed on a yearly basis.
