The present Operational Level Agreement (“the Agreement”) is made between **EGI Foundation (the Customer)** and **IFCA-LCG2 (the Provider)** to define the provision and support of the provided services as described hereafter. Representatives and contact information are defined in Section 6.

The OpenBioMaps+ community offers online tools for researchers and conservationists to manage biodiversity data. As a tool, it works in a production environment (e.g. for national parks). The purpose of the system is to establish a connection between research and nature conservation, therefore they are constantly trying to carry out research tasks with it, which are connected to databases and have a significant need for computers. In this sense, the system is in a continuous pilot state.

The User is a consortium represented by the **University of Debrecen**.

This Agreement is valid from **01/05/2021 to 30/06/2023**.

Once approved, **this Agreement is automatically renewed**, as long as the Provider does not express a decision to terminate the Agreement at least a month before the end date of the Agreement.

The Agreement was discussed and approved by the Customer and the Provider **01/09/2021**.

The Agreement extends the Resource Center OLA<sup>1</sup> with the following information:

## 1 The Services

Possible allocation types:

- Pledged - Resources are exclusively reserved to the Community and the job will be executed immediately after submission.
- Opportunistic - Resources are not exclusively allocated, but subject to local availability.
- Time allocation - Resources are available in fair share-like mode for a fixed time period.

Possible payment mode offer:

- Sponsored - Model where the customer uses services that are funded, or co-funded by the European Commission or government grants.
- Pay-per-use - Model where customers directly pay for the service used.
