The present Operational Level Agreement (“the Agreement”) is made between **EGI Foundation (the Service Provider)** and **IFCA-LCG2 (the Component Provider)** to define the provision and support of the provided services as described hereafter. Representatives and contact information are defined in Section 6.

IceCube<sup>1</sup> is the world’s premier facility to detect neutrinos with energies above approximately 10 GeV. It is a pillar for NSF’s MMA program, one of the top 10 NSF priorities. The detector is located at the geographic South Pole, and was completed at the end of 2010. It is designed to detect interaction of neutrinos of astrophysical origin by instrumenting over a gigaton of polar ice with 5,160 optical sensors. The sensors are buried between 1,450 and 2,450 meters below the surface of the South Pole ice sheet in a hexagonal grid. The project is a recognized CERN experiment (RE10).

The IceCube collaboration<sup>2</sup> has discovered extremely energetic neutrinos from the cosmos and initiated a joint neutrino-electromagnetic emission MMA observation which found the first confirmed high-energy astrophysical neutrino point source from the active galactic nucleus TXS 05060+056. This former discovery was recognized as the Physics World Breakthrough of the Year Award for 2013. The latter made IceCube one of the pillars on which the NSF is building an MMA program that has been declared a high-level priority area for the future.

The Customer is a consortium represented by the **University of Wisconsin-Madison**<sup>3</sup>.

This Agreement is valid from **01/01/2022** to **30/06/2023**.

Once approved, **this Agreement is automatically renewed**, as long as the Component Provider does not express a decision to terminate the Agreement at least a month before the end date of the Agreement.

The Agreement was discussed and approved by the EGI Foundation and the Component Provider on **01/07/2022**.

The Agreement extends the Resource Centre OLA [1] with the following information:

## 1 The Services

Possible allocation types:

- **Pledged** - Resources are exclusively reserved to the Community.
- **Opportunistic** - Resources are not exclusively allocated, but subject to local availability.
- **Time allocation** - Resources are available for a fixed time period.

### 6.2 Regular reporting

### 6.3 Violations

The Component Provider commits to inform the EGI Foundation, if the Agreement is violated or violation is anticipated.

The following rules are agreed for communication at the event of the violation:

- In case of violations of the Services targets for **four months (within reporting period)** or **two consecutive months**, the Component Provider will provide justifications to EGI Foundation.

- In case of service target violation, the Component Provider must provide justifications and a plan for service enhancement **within 10 working days** from the date of the notification to/from the EGI Foundation.
  - In case of no or unsatisfactory justification and plan for improvement, EGI Foundation reserves the right to replace the Component Provider.
- EGI Foundation will notify the supporting Component Provider in case of suspected violation via the EGI Service Desk (Section 3). The case will be analysed to identify the cause and verify the violation.

## 6.4 Escalation and complaints

For escalation and complaints (a customer complaint is a customer's expression of dissatisfaction with an EGI service, either orally or in writing), EGI Foundation contact (Section 6.1) point shall be used, and the following rules apply.

- In case of repeated violation of the Services targets for **four months (within reporting period) or two consecutive months**, a review of the Agreement will take place involving the parties of the Agreement.
- Customer complaints or concerns about the Service(s) provided directed to the EGI Foundation contact will be shared with corresponding Component Providers.

## 7 Information security and data protection

As defined by the EGI Default Operational Level Agreement<sup>7</sup>.

The following rules for Information Security and data protection must be enforced by the Component Provider:

- Make every effort to maximise the security level of users' data and minimise possible harm in the event of an incident. Incidents must be immediately reported to the EGI Computer Security Incident Response Team (CSIRT) according to the SEC01 procedure<sup>8</sup>.
- For the processing of access data (i.e. data related to authentication going through Check-in), the Customer's Home Organisation, EGI Foundation (the Service Provider) and the Component Providers hold the role of Data Controllers. As part of the authentication process, personal data are transmitted between these data controllers based on the consent of the user (Data Subject). In this context, and unless it has been agreed to use a different model, there is no need for having any particular data processing agreement in place.
- In the case the Customer, as a Data Controller, is processing any personal data (research data, personal data of their users or visitors) on the provided resources, EGI Foundation holds the role of Data Processor and the Component Provider the role of sub-processor. In that

situation, when the Data Controller requests having a DPA signed with EGI Foundation as a processor, an additional subcontractor agreement has to be signed between EGI Foundation and the Component Provider as sub-processor.

- The Component Provider must comply with the EGI Policy on the Processing of Personal Data<sup>9</sup> and provide a Privacy Policy. This Privacy Policy can be based on the Privacy Policy template provided by the AARC Policy Development Kit (PDK)<sup>10</sup>.
- The Component Provider must enforce the Acceptable Use Policy and Conditions of Use<sup>11</sup>.
- The Component Provider must comply with all principles set out by the GÉANT Data Protection Code of Conduct<sup>12</sup> (v1.0).
- Security incidents affecting the services described in Section 1 must be reported to [abuse@egi.eu](mailto:abuse@egi.eu) within 4 hours after their discovery and handled according to [SEC01: EGI CSIRT Security Incident Handling Procedure](#).
- The Component Provider must meet all requirements of any relevant EGI policies or procedures<sup>13</sup> and also must be compliant with the relevant national legislation. Regarding EGI requirements, please refer to the following reference documentation:

## 8 Responsibilities

### 8.1 Of the Component Provider

- The Component Provider shall not terminate the virtual machines without agreement with EGI Foundation.
